On the one hand, the marking of the matrix depends on the interpretation of modality to the language (the interpretation, which may be determined by context). For example, for the sentence ABABAB, the sentence Modal for Modal is semantically irrelevant, but it is semantically relevant for the sentence Modal for ABABAB. In addition, the matrix example of modality represents the type of modality. For example, the sentence ABABAB means that John likes Mary. However, if one writes: Mary likes John, then John refers to the context of the sentence, and not to the matrix. This distinction is important, as long as one is interested in computational approaches that are based on the syntactic model of lexical items (for example, the Lexical Quality Grammar, the Lexical Functional Grammar, etc.). The modal verb can also be used to express other types of subjective language. Examples of the use of modal verbs can be found in Example (5), where the verb CAN expresses subjectivity by suggesting that the event is not true. The use of modal expressions in negation is commonly interpreted as a cue that modality is not present in the negated event. This assumption is very common in modern negation grammars, where negation is either described as a modal operator (see e.g. Lee 1993) or as a prepositional phrase with a coresponding negation marker (see e.g. Hartmann 1994; see also Smorynski 2005). These approaches have been developed in a detailed way in Gerlach et al. 2004 and Smorynski 2005, who argue that a stronger negation sense (e.g. not not) should be allowed in the representation of negation. They conclude that negation is represented in a linguistically and semantically less restrictive way in those systems that represent negation from the point of view of an agent. Modal verbs should also be understood as assertive or tentative modals that can be used to express information on the negation of the event denoted by the main verb, as in Example (6). (6)a. John didn't know how to speak Spanish.

The last aspect on negation that we will mention in this paper is the treatment of negation as an expression of conditionals. This issue has been addressed from both an empirical and a formal point of view. By empirical, we mean the use of negation markers in language, as in not John cried, where the proposition

expressed by the negation is a subordinate clause. Conversely, by formal, we refer to formal linguistics, where negation markers are treated as adjuncts to the sentences or as operators over conditional sentences. The latter approach is predominant in linguistics: the use of negation as an adjunct to conditional sentences has been discussed from a syntactic perspective by

Anderson and Anderson 1989, who highlight the need for a syntactic account of negation, and by Cruz-Ferreira et al. 1995, who present a view of negation based on finite state grammars. Recent work has been carried out from different perspectives. Tirrell 2008 analyses the use of negation in conditional clauses as an extension of the EC conditional schema,

discussed by Juarrero 2005, while Fernández 2006 presents a formal treatment of negation as an operator. Negation also appears in the studies of Wolfram 2003 on aspectual adverbials and in the study of contrastive negation by Murray et al. 2003. Modal operators, quantified assertions, and indefinite yes-no questions have been addressed in the computational linguistics

literature. The quantified assertions and the definite yes-no questions are represented in a general language (e.g. {John likes the TV} and {John would like the TV, respectively). The general language allows us to treat modal operators as special cases of quantified assertions. Furthermore, indefinite yesno questions can be treated as well-formed sentences where the answer is

unknown because we have not yet chosen an answer for the speaker. 5ec8ef588b
